

Your privacy is critically important to us. At Selective Corporate Internship Program we have a few fundamental principles:

- We don't ask you for personal information unless we truly need it. (We can't stand services that ask you for things like your gender or income level for no apparent reason.)
- We don't share your personal information with anyone except to comply with the law or protect our rights.
- We don't store personal information on our servers unless required for the on-going operation of one of our services.
- We aim to make it as simple as possible for you to control what's visible to the public, seen by search engines, kept private, and permanently deleted.

Selective Corporate Internship Program LLC. ("Selective Staffing Corporate Internship Program (SCIP or Selective Corporate Internship Program") operates SCIPLeaders.org. It is Selective Corporate Internship Program policy to respect your privacy regarding any information we may collect while operating our website or using related third party applications.

### **Website Visitors**

Like most website operators, Selective Corporate Internship Program collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Selective Corporate Internship Program' purpose in collecting non-personally identifying information is to better understand how Selective Corporate Internship Program' visitors use its website. From time to time, Selective Corporate Internship Program may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Selective Corporate Internship Program also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments. Selective Corporate Internship Program only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that blog commenter IP addresses are visible and disclosed to the administrators of the blog where the comment was left.

### **Gathering of Personally-Identifying Information**

Certain visitors to Selective Corporate Internship Program' website or related third party applications choose to interact with Selective Corporate Internship Program in ways that require Selective Corporate Internship Program to gather personally-identifying

information. The amount and type of information that Selective Corporate Internship Program gathers depends on the nature of the interaction. Those who engage in transactions with Selective Corporate Internship Program are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, Selective Corporate Internship Program collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with Selective Corporate Internship Program. Selective Corporate Internship Program does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

### **Aggregated Statistics**

Selective Corporate Internship Program may collect statistics about the behavior of visitors to its website. For instance, Selective Corporate Internship Program may monitor the most popular posts on SCIPLeaders.org.com and may display this information publicly or provide it to others. However, Selective Corporate Internship Program does not disclose personally-identifying information other than as described below.

### **Protection of Certain Personally-Identifying Information**

Selective Corporate Internship Program discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Selective Corporate Internship Program's behalf or to provide services available at Selective Corporate Internship Program's website, and (ii) that have agreed not to disclose it to others. Selective Corporate Internship Program will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Selective Corporate Internship Program discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental request, or when Selective Corporate Internship Program believes in good faith that disclosure is reasonably necessary to protect the property or rights of Selective Corporate Internship Program, third parties or the public at large. Selective Corporate Internship Program takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

### **Cookies**

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Selective Corporate Internship Program uses cookies to help Selective Corporate Internship Program identify and track visitors, their usage of Selective Corporate Internship Program website, and their website access preferences. Selective Corporate Internship Program visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Selective Corporate Internship Program's

website, with the drawback that certain features of Selective Corporate Internship Program' website may not function properly without the aid of cookies.

### **Business Transfers**

If Selective Corporate Internship Program, or substantially all of its assets were acquired, or in the unlikely event that Selective Corporate Internship Program goes out of business or enters bankruptcy, user information would be one of the assets that is transferred or acquired by a third party. You acknowledge that such transfers may occur, and that any acquirer of Selective Corporate Internship Program may continue to use your personal information as set forth in this policy.

### **Ads**

Ads appearing on any of our website may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognize your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. This Privacy Policy covers the use of cookies by Selective Corporate Internship Program and does not cover the use of cookies by any advertisers.
